- Joint Ventures (JV) or Consortiums are not permitted to participate in this EOI.
- Proposals must be accompanied by a non-refundable bid document fee of Rs.5,000/- and an EMD/Bid Security of Rs.50,000/- (refundable) in favor of The Secretary, Brahmapur Development Authority, Brahmapur payable at Brahmapur. Bids without the bid document fee and EMD shall be rejected outright.
- EMDs of unsuccessful bidders will be refunded without interest immediately after completion of the EOI process. The EMD of the successful bidder will be retained as a Security Deposit along with a 5% deduction from the bill and returned without interest after successful completion of the warranty period.
- A Letter of Intent (LOI) will be issued to the L1 bidder and upon acceptance, a formal agreement will be executed with the selected bidder.
- The warranty period for the supplied and fixed LED Strip Lights must be at least 2 years. Any defects arising during this period must be rectified or replaced by the agency at no additional cost within 3 days from the date of written or e-mailed intimation to the agency.
- The successful bidder must complete the installation within 30 days from the date of issue of the work order. Any extension of time shall be at the sole discretion of the BeDA Authority. Failure to complete the work on time shall attract a penalty of 1% of the accepted contract value per week, up to a maximum of 10% of the contract value.
- Non-compliance with the terms of the EOI or failure to deliver the required services shall lead to termination of the work order and forfeiture of the Security Deposit, at the discretion of the Authority.
- The qualified bidder shall supply and fix LED Strip/Rope Lights at various locations within the BeDA area. Specific location details will be provided along with the work order.
- The actual quantity or scope of the work order is subject to variation by up to 25% more or less at the discretion of the Authority.
- All LED Strip Lights must be uniform in design, quality and specification across all locations. Any variation will be unacceptable and will require immediate replacement at the bidder's cost.
- All delivery, freight, installation, commissioning and related charges shall be borne by the bidder. No separate payment shall be made on these accounts.
- The Authority reserves the right to engage one or more agencies after price negotiations, if required.
