
### Expression of Interest (EOI) for Short Term License for Operation and Management of Bus Terminal at Haladiapadar, Brahmapur





## 1. Introduction:

Berhampur Development Authority (BeDA) invites sealed Expressions of Interest (EOI) from eligible agencies for grant of a Short-Term License for the operation and management of the Bus Terminal situated at Haladiapadar, Brahmapur, strictly in accordance with the terms and conditions specified herein.

## 2. Definitions

For the purpose of this EOI, unless the context otherwise requires:

- **“Authority”** means Berhampur Development Authority (BeDA).
- **“Licensee”** means the agency selected through this EOI process and granted the short-term license.
- **“Bus Terminal Premises”** means the bus Terminal located at Haladiapadar, Brahmapur, including the office complex, toilet complex and all allied facilities.

## 3. Nature of License

- 3.1 The engagement shall be treated strictly as a Short-Term License.
- 3.2 This license shall not create any right, title, interest, lease or tenancy in favour of the Licensee.
- 3.3 The Authority shall retain absolute ownership, possession and control over the premises at all times.

## 4. Scope of Work

### 4.1 General Operation & Management

The Licensee shall be responsible for:

- a. Day-to-day operation, supervision and management of the Bus Terminal.
- b. Regular Sweeping, cleaning, upkeep and overall maintenance of the entire bus Terminal premises.
- c. Ensuring orderly entry, exit and parking of buses and auto-rickshaws within the premises.
- d. Maintaining discipline, preventing congestion and ensuring smooth movement of vehicles and passengers within the bus Terminal premises.
- e. Ensuring timely switching ON and OFF of all lights and electrical installations at the Bus Terminal.
- f. Ensuring orderly entry, exit and parking of buses and auto-rickshaws.
- g. Maintaining discipline and preventing congestion within the premises.
- h. The agency shall be responsible for payment and timely deposit of the monthly electricity charges for the premises.**
- i. The successful bidder will be responsible for maintenance of all the items up to a limit of Rs.10,000/- per item. Any cost above that will be borne by BeDA only

on structural damage. For any breakage/ theft of items, the agency will be held responsible and will bear the cost of the same.

#### 4.2 **Collection of Entry Fees**

The Licensee shall collect entry/parking fees at the rates approved by the Authority, as detailed below:

- **Bus Entry Fee:** Rs.30 /- per entry
- **Night Halt Charges of Bus:** Rs.50/- per Night
- **Auto-rickshaw Entry Fee:** Rs.10/- per entry
- **Bike Terminal Fee:** Rs.10/- (per 2-hour, additional Rs.5/- per each 2 Hour)

The above rates are subject to revision by the Authority from time to time and shall be binding on the Licensee as well as on all users of the facility.

**Note:** *The average daily turnout of buses at the Temporary Bus Terminal is approximately 200 to 250 numbers per day. Each bus shall be permitted to halt for a maximum duration of one (01) hour only within the bus Terminal premises.*

#### 4.3 **Advertisement Rights**

- a. Collection of revenue from advertisements within the bus Terminal premises, including on walls, sheds, hoardings, etc., shall be permitted only with prior written approval of the Authority.
- b. Any structural requirements, if any, for Advertisement purposes shall be borne by the selected Agency at its own cost.
- c. All advertisements shall strictly comply with the applicable rules and regulations and shall not obstruct movement, visibility, or public safety.
- d. The content of all advertisements shall be subject to prior approval of the Authority before display.

#### 4.4 **Manpower Deployment**

The Licensee shall deploy an adequate number of trained personnel for:

- Fee collection
- Cleaning and sanitation
- General supervision and management
- Watch and ward

All manpower shall be engaged at the cost, risk and responsibility of the Licensee.

#### 4.5 **Water Supply, Sanitation & Toilet Management**

- a. Ensuring proper water management within the bus Terminal premises, including uninterrupted water supply, prevention of waterlogging, regular maintenance of drainage systems and judicious use of water.
- b. Proper operation, upkeep and maintenance of the toilet complex and its surrounding areas.
- c. Use of the toilet facilities shall be free of cost for all commuters, without any exception.
- d. The agency shall ensure proper hygiene, cleanliness and regular sanitation of the toilet complex at all times and shall provide special care and enhanced services during peak hours.

#### 5. **Information to the Bidder**

- 5.1 An **Earnest Money Deposit (EMD)/ Security Deposit of ₹100,000/-** (Rupees One Lakh) only and **Document Fee of ₹10,000/-** (Rupees Ten Thousand) only shall be submitted separately in the form of **Demand Drafts (DD)** drawn from any Nationalized/Scheduled Bank in favour of “**The Secretary, BeDA, Berhampur**”, payable at Berhampur, along with the Technical Bid.
- 5.2 The Document Fee is **non-transferable and non-refundable**.
- 5.3 **No exemption or relaxation** in EMD shall be allowed to any bidder.
- 5.4 EMD of unsuccessful bidders shall be refunded **without interest** within 30 days from the date of opening of the Financial Bid or closure/cancellation of the bidding process.
- 5.5 Financial proposals shall be examined for compliance with the prescribed format.
- 5.6 Bids must be **properly sealed and closed using gum**. Bids not properly sealed shall be rejected outrightly.
- 5.7 Late bids, conditional bids, incomplete bids or bids received through telegraphic means shall not be considered.  
The bidder quoting the **highest financial offer** shall be declared the successful bidder.

#### 6. **Eligibility & Qualification**

The Expression of Interest (EOI) is invited from registered agencies preferably from Sanitation Agencies, Bus Operators, Parking Management Agencies etc.

The applicant shall:

- a. Shall be registered under relevant statutory provisions.
- b. Have experience in management of Sanitation, transport management, parking or public utility services (preferred).
- c. Not have been blacklisted by any Government Department, PSU or ULB.

**Note: Having a Registered Office within Ganjam district shall be the primary eligibility criterion.**

## **7. Period of License**

- The license shall be valid for a period of 01 (One) year from the date of execution of the agreement and may be extended at the sole discretion of the Authority, subject to satisfactory performance of the Licensee.
- The license fee shall be upgraded in the event of enhancement of the entry fee, based on mutual consent of both parties.

## **8. Financial Conditions**

- 8.1 The Licensee shall pay the Monthly License Fee as quoted and accepted by the Authority.
- 8.2 The License Fee shall be deposited on or before the 7th day of every month.
- 8.3 Delay in payment shall attract penal interest @ 12% per month.
- 8.4 Default in payment for three (03) consecutive months shall result in cancellation of the license and forfeiture of the Security Deposit, without any further notice.
- 8.5 All applicable taxes, duties, and statutory levies shall be borne by the Licensee.

## **9. Security Deposit / Performance Security**

- 9.1 The successful bidder shall deposit a Security Deposit equivalent to the annual license fee in the form of a Demand Draft.
- 9.2 The Security Deposit shall be liable for forfeiture in case of:
  - a. Breach of terms and conditions
  - b. Unsatisfactory performance  
Premature termination due to fault of the Licensee
- 9.3 Penalty & Liquidated Damages  
Penalty up to Rs. 500 /- per instance may be imposed for:
  - a. Poor sanitation
  - b. Irregular manpower deployment

Repeated violations shall lead to termination of license.

## **10. Termination of License**

- 10.1 The Authority reserves the right to terminate the license at any time by giving 15 (fifteen) days' notice without assigning any reason.
- 10.2 In case of serious violations, the license may be terminated without notice.  
Upon termination, the Licensee shall vacate the premises immediately and hand over peaceful possession without any claim for compensation.

## **11. Force Majeure**

Neither party shall be held responsible for failure to perform obligations due to force majeure events such as natural calamities, riots, strikes or Government restrictions.

## **12. Submission of EOI**

The EOI shall contain Technical Credentials only and must be submitted in a sealed envelope, superscribed as:

## **13. Evaluation & Selection**

13.1 EOIs shall be evaluated by a committee constituted by the Authority.

13.2 Shortlisted agencies may be called for negotiation.

13.3 The decision of the Authority shall be **final and binding** on all bidders.

## **14. Jurisdiction & Legal Validity**

All disputes shall be subject to the jurisdiction of the competent courts at Brahmapur, Odisha only.
